**GENERAL NOTICE ON USING TANZANIA NATIONAL e-PROCUREMENT SYSTEM (TANePS) FOR THE TANZANIA EI ACCOUNTABILITY AND GOVERNANCE ENHANCEMENT PROJECT, P162493**

The Government of the United Republic of Tanzania has developed the Tanzania National e-Procurement System (TANePS) which was piloted 2018 and it is being rolled out to all public bodies now. As per the government policy by December 2020, all procuring entities using public funds must be trained and use TANePS. Consequently, in June 2020, the World Bank conducted an assessment aimed at evaluating TANePS suitability to be used for the procurement activities of the projects funded by the Multilateral development Banks (MDBs), specifically the World Bank and African development Bank. The assessment concluded that the TANePS is compliant with the MDB e-Government Procurement Guidelines and as such can be used in the procurement activities of the projects funded by the World Bank.

Therefore, Tanzania **Extractive Industries Transparency Initiative (TEITI) through Ministry of Minerals** informs the general public, Suppliers, Consultants and Service Providers that from September 1<sup>st</sup>, 2021 the World Bank financed procurement activities for the **Tanzania EI Accountability and Governance Enhancement Project, P162493** will be processed through TANePS. Thus, all prospective bidders interested to participate in the bid opportunities under this project are required to be registered as user of the system. The registration is open to all local and international bidders. Bidders already registered to use TANePS need not to register again. All bidders are encouraged to use the system User Guides or Suppliers Training Videos which can be accessed at <https://www.taneps.go.tz/apps/home.do> Further, bidders are strongly

advised to download “D0 End-User Supplier Manual” which can be found through the ‘User Manual” link under “Quick Guide” section on the TANePS home page.
