RE: ANNUAL DISSEMINATION PROGRAM ON APPLICATION OF TANePS, PUBLIC PROCUREMENT ACT CAP 410, PROCUREMENT IMPLEMENTATION TOOLS AND PROCUREMENT CONTRACT MANAGEMENT FOR THE FINANCIAL YEAR 2022/2023

Reference is made to the above subject.

2. PPRA has prepared intensive dissemination programs on the application of TANePS, Public Procurement Act Cap 410, Procurement Implementation Tools, and Procurement Contract Management for procurement stakeholders including Suppliers, Contractors, Consultants, Accounting Officers, members of Tender Boards, staff from Procurement Management Units (PMUs), User Departments, Internal Auditors, and Legal Officers.

3. These programs have been designed to equip knowledge and skills to personnel who have responsibilities in handling procurement or tendering activities within procuring or bidding entities respectively. These programs will be conducted monthly from September 2022 and are expected to continue through June 2023.

4. TANePS dissemination to procuring entities will be offered in five working days separately from PPA dissemination which will be offered in four working days. Each participant from procuring entities will be required to pay TZS. 550,000.00 Per dissemination session on TANePS or PPA. Dissemination sessions on TANePS to suppliers, consultants, and contractors will be conducted for one day without paying participation fee.
